

Waiver of Liability, Release, and Indemnification of All Claims

In consideration of my participation in the Intown Jewish Preschool Summer Program, (hereinafter known as "Summer Programs") programs and facilities, I execute this Waiver of Liability, Release, and Indemnification of All Claims to confirm my understanding regarding certain risks inherent in participation in Intown Jewish Preschool and Chabad Intown facilities and programs.

1. I understand that the Coronavirus SARS-CoV-2, (which causes the disease now commonly known as COVID-19) ("COVID-19") is an extremely contagious virus that spreads easily through person-to-person contact. Federal and state authorities recommend social distancing as a means to prevent the spread of the virus. Contracting COVID-19 can lead to severe illness, personal injury, permanent disability, or death. I acknowledge that participating in summer programs or accessing Intown Jewish Preschool and Chabad Intown facilities could increase my risk of exposure to and contracting of COVID-19. Intown Jewish Preschool and Chabad of Intown in no way warrants, guarantees, or represents that COVID-19 infection will not occur through participation in the summer programs or accessing Intown Jewish Preschool and Chabad of intown facilities.

2. I acknowledge that social distancing measures as recommended by CDC guidelines will not be in place in the Summer Programs or between participants. (Refer to measures being taken in the Updated Standards of Safety and Precaution for Re-Opening of Intown Jewish Preschool)

3. I hereby certify that I have full knowledge of the nature and extent of the risks inherent in accessing Intown Jewish Preschool and Chabad Intown facilities or participating in programs at Intown Jewish Preschool and Chabad Intown facilities and I hereby acknowledge that I am voluntarily, knowingly, consciously, and willingly ASSUMING SAID RISKS.

4. I hereby certify that I am not currently infected with COVID-19 and that I am not exhibiting symptoms of COVID-19, including fever, cough, sore throat, shortness of breath or any other symptoms publicized by the Centers for Disease Control and Prevention ("CDC") as indicative of a COVID-19 infection*. Furthermore, I agree to notify Rabbi Schusterman, Dena Schusterman or Elie Estrin via admin@intownjewishpreschool.org immediately if I, or any member of my household, become infected with COVID-19 or develop or exhibit any such symptoms.

5. I understand that the CDC has declared that certain segments of the population are more vulnerable to COVID-19 infections and are more susceptible to more serious outcomes if infected, including death, and therefore need to take extra precautions.* I hereby acknowledge that if I am in one of these vulnerable groups that I am choosing to participate in Summer Programs and Intown Jewish Preschool and Chabad Intown facilities and have not received any representation, guarantee, or

warranty from Intown Jewish Preschool and Chabad Intown that its programs or facilities have been made suitable for increased protection of these vulnerable groups.

6. I agree to notify Rabbi Schusterman, Dena Schusterman or Elie Estrin at admin@intownjewishpreschool.org if I or anyone in my household believes that we have been exposed to any person infected with COVID-19 or if we have travelled or will travel to an area of increased risk for contraction of COVID-19. I understand that in any of these events I or members of my household may be refused admission to Intown Jewish Preschool and Chabad Intown facilities or programs for at least 14 days based on increased risk of COVID-19 exposure to other Summer Program participants.

7. I understand and agree that Summer Program staff may check my temperature prior to entry into any Intown Jewish Preschool and Chabad Intown facility or participation in any Summer Programs. I understand that if I have a temperature of 100 degrees farenheight or higher I will not be admitted into any Intown Jewish Preschool and Chabad Intown facility or program.

8. I understand and agree that as part of my participation in Summer Programs or use of Atlanta Jewish Preschool and Chabad Intown facilities, I or other members of my household may be required to wear face coverings while interacting with Intown Jewish Preschool and Chabad Intown facility staff or other program participants. I agree, on behalf of myself and other members of my household, that refusal to wear face coverings may result in exclusion from Intown Jewish Preschool and Chabad Intown facilities or programs.

9. I am aware that participation in Intown Jewish Preschool and Chabad Intown facilities or programs may expose me to a contagious illness, including but not limited to COVID-19, and I agree to INDEMNIFY AND HOLD HARMLESS Intown Jewish Preschool and Chabad Intown and Summer Program for any possible exposure or illness that may result due to my attendance and participation in Summer Programs or access of Intown Jewish Preschool and Chabad Intown facilities.

10. In consideration of my participation in the Summer Programs and ongoing access Intown Jewish Preschool and Chabad Intown facilities, I, _____, the undersigned participant, on behalf of myself, my heirs, representatives, executors, administrators, and assigns, HEREBY DO RELEASE Intown Jewish Preschool and Chabad Intown, its officers, directors, employees, volunteers, agents, representatives and insurers ("Releasees") from any causes of action, claims, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I, my heirs, representatives, executors, administrators and assigns may have, now or in the future, against Intown Jewish Preschool and Chabad Intown and Summer Program on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to the use of the Intown Jewish Preschool and Chabad Intown facilities and equipment or participation in the Summer Programs whether that participation is supervised or

unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

11. I agree that this Waiver of Liability is complementary to, and does not negate, replace, or amend any prior Waivers or documents executed by me in my association with or prior participation in Intown Jewish Preschool and Chabad Intown programs.

12. I certify that I am of lawful age and otherwise legally competent to sign this agreement. I further understand that the terms of this agreement are legally binding and certify that I am signing this agreement, after having carefully read it, of my own free will. I further understand that by signing this agreement, I am giving up my right to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of my participation in Summer Programs, Intown Jewish Preschool and Chabad Intown facilities, now or at any time in the future.
